### **CITIZEN COMMENT**

### **MULTI PURPOSE EVENT CENTER**

Tony Beckstead was in attendance to ask permission to hold a "Due West" concert. The band is willing to do the concert for \$2,000.00. Sounding and lighting would cost around \$750.00 and approximately another \$750.00 for advertising. Tony feels this concert should draw a main stream crowd and feels it would be a good concert. He also stated that we need to advertise well and the county would be paying half. Allowing a beer garden was discussed. Tim Smith likes the idea of giving a concert another chance. Tim suggested that we donate a portion of the ticket sales to a family in the Circleville area and one in the Tropic area who are having some major medical problems at the present time.

Mayor Talbot asked the council if they were in agreement of supporting a concert with the details to be worked out at a later date.
