**Tim Smith moved, seconded by Eric Houston to adopt the agenda as outlined. The motion passed with all in favor.**

**BOARD OF ADJUSTMENT APPOINTMENTS**

Allen K. Henrie explained that most requests made to this board regard problems due to hardships out of the control of the property owner. The board does not meet often, and their decision is final unless over ruled by the courts.

Allen K. Henrie handed out a list of the current Board of Adjustments committee members. He asked the council to look over the list and recommend some new members. The current chairman of the board has moved out of town and some of the other member's terms have expired.

Mayor Lori Talbot asked the council members for suggestions of people who would be good to serve on this committee. Several names were suggested. Allen K. Henrie is to call the current members as well as those who were suggested to serve on this board.

Other names were suggested, and these people will be contacted and asked if they would be willing to serve.

**Eric Houston moved, seconded by Nick Reynolds to instruct Allen K. Henrie to ask the individuals discussed if they would be willing to serve. The motion passed with all in favor.**

## **BUDGET ISSUES**

Mayor Lori Talbot put this item on the agenda and asked council members if they in agreement with the budget presented.

John Orton asked about the employees insurance pay out and how that was being handled. Mayor Talbot responded it was not the employees' fault the insurance payout was offered to the employee when they were hired.

Tim Smith asked if any new employees would have the option of the insurance payout. Allen K. Henrie said it was capped for current employees and will not be available to any future employees. Eric Houston has some concerns with the insurance payout concept. Tim stated that he has concerns with the concept but feels the employees should not be punished for it. Tim has been thinking about the insurance payout concept for a couple of weeks and feels in the end we may be where we need to be on this issue.

Allen read the motion from last year on June 8, 2010 which states:

**"Lori Talbot moved, seconded by Eric Houston to go with revised plan Tim Smith proposed lowering insurance pay out cap to \$6,000.00 per year and giving a \$2,600.00 raise to full time city employees with exclusion of Tony Beckstead. In one year the city council will look into a Health Savings Account for the employees putting in the maximum allowed out of the \$6,000.00 pay out cap. John Orton opposed. The motion passed."**

Nick Reynolds feels our city employees are underpaid and does not feel we should hurt the employees.

Eric Houston asked about the possibility of purchasing the Cameron Motel for additional parking. Allen K. Henrie reported the city has looked into funding to help with improvements to the property. John Orton would like to send a letter of commendation to Alex Nay for all of the cleanup and improvements he has made on the house north of the Cameron Motel across from the Post Office.

Allen K. Henrie stated he is proud of where we are with the budget. At some point there are going to be items we need to purchase such as company trucks, upgrading the landfill cat, a roller, heating/carpet in the city office/library, and the railing around the skateboard park. At some point the city will need to add these items into the budget. The budget being presented is a conservative one.

Troy Pollock suggested the city look into acquiring a truck with a snow plow to take care of the areas in town currently being cleared with the backhoe, which is very time consuming

**Old Fire Station** - The judge wants to hear all the facts before a decision is made regarding the eviction of Rebecca Gregg. The pre-trial will be on August 4, 2011. The renter was informed she should be putting rental money owed to the city in an escrow account.
