OPENING CEREMONY

Council Member Mike Sarles conducted the opening ceremony.

ADOPTION OF THE AGENDA

APPROVAL OF THE MINUTES

OFFICER REPORT

CHILDREN'S JUSTICE CENTER

Teresa Wood and Leanne Bowman discussed the purpose of a Children's Justice Center. Currently Garfield County is the only county in Utah without a Children's Justice Center. The City Council stated they would support and help where possible.

CHANAY NOWERS FENCE

Chaney Nowers discussed with the Council possibilities of putting a fence between where he runs his cows and the industrial park. He asked for some help with the cost of building the fence. Mayor Soper will contact the BLM to see if they will provide any fencing materials.
