**Food Vendors:** Food vendors are required to obtain a temporary food establishment permit from the **Utah Health Department** **before arriving at the event.**

Panguitch Valley Balloon Rally will not be responsible for the safety of exhibits against theft, fire, robbery, accident, or any other destructive cause, for any injury that may arise to the public in the rented area, or to the vendor/exhibitors or their employees while on City grounds.

**No overnight security will be provided by the City.**

The vendor/exhibitor agrees to indemnify and save harmless the City of Panguitch and Panguitch Valley Balloon Rally Organization, their officers, agents and employees from any and all claims, causes of action and suits occurring or resulting from any damage, injury, or loss to any person or persons including, but not limited to, persons to whom the vendor/exhibitor may be liable under any Worker's Compensation Law and the vendor/exhibitor himself/herself and from any loss, damage, cause of action, claims or suits from damages including but not limited to loss of property, goods, wares, or merchandise, caused by, arising out of, or in any way connected with the exercises by the vendor/exhibitor of the privileges granted therein.

Note: All activities involving the hot air balloons are weather permitting. In the event of inclement weather some activities may be canceled: this is at the discretion of the Balloon Meister and/or the pilots.
