ADOPTION OF THE AGENDA

Mike Sarles moved, seconded by Paul Dastrup to adopt the agenda. The motion passed with all in favor.

OFFICER REPORT

The council discussed options for a pavilion at the baseball park.

DEPARTMENT REPORTS/CALENDAR

Baseball committee- Event Coordinator Steven Lee held a meeting with the baseball committee. They came up with some ideas to help with the use and the maintenance of the fields.

ULCT-Council Member Mike Sarles attended the ULCT conference.

Half Marathon- In the past the City has donated \$250 to the Bryce Canyon Half Marathon. City manager Lori Talbot asked if that is what the council would like to do again. The council agreed with that amount.

Mini Excavator- The Mayor is going to look at a mini excavator that might be purchased for the city.

Social hall-The basement is being finished up and the heating system needs to be installed. Current owners of social hall keys will need to bring in their old key to trade for a new key. The new keys will be numbered and say do not duplicate on them.

School Board- Mayor Kim Soper met with the School Board about the modular buildings that will be available after the new Panguitch Elementary is built.
