Council Member Trudi Owens was absent.

The meeting was called to order at 6:30 pm.

## ADOPTION OF THE AGENDA

Paul Dastrup moved, seconded by Mark Boshell to adopt the agenda. The motion passed with all in favor.

## APPROVAL OF THE MINUTES

Alan Johnson moved, seconded by Mike Sarles to approve the minutes. The motion passed with all in favor.

## EVENTS UPDATE – STEVEN LEE

Event Coordinator Steven Lee updated the council on current city events. The baseball committee has not met due to social distancing. Spring baseball and softball have been canceled. The Icebreaker Tournament will likely be cancelled, but hopefully the Pat Dix Tournament will happen in July. Steven has been working on organizing a chamber of commerce and has a few volunteers. The Women Rock Business event has been postponed. The Joanne Miller beautification week will be May 11-16, 2020. Citizens will be encouraged to clean up and beautify without social gathering. At this time plans are moving forward for the Balloon Rally. Sponsors are lacking funds due to Covid19. With less funds coming in Steven is working on reducing costs of the event.

People may call for an appointment. Bryce Canyon is closed. Escalante has many areas closed. The Panguitch Municipal airport received \$20,000 from the Federal CARES act for maintenance which will buy a tractor and a brush hog. Garfield Memorial Hospital has limited access. Currently there is one positive case for Covid-19 in Garfield County with people being tested daily.

**Triple C** – Mold has been found in a conference room of the Triple C Arena. The room has been sealed off and the mold tested. Test results are expected back by Friday.

**Summer help** – The Summer help positions have been advertised in the newspaper.

**Well House** – The well house needs a door and then it will be complete.

**Bike path** – The bike path will be paved this summer when UDOT does highway 143.

**Budget** – A rough draft of the budget has been completed.

**Fire Station** – The Fire station will be getting new heating and air.
