ADOPTION OF THE AGENDA

The Balloon Rally had a few balloons light up for the balloon glow. Steven thanked the many people who helped with the Balloon Rally including Mark Boshell, Trudi Owens and Lori Talbot. July 4th had a bigger attendance than was expected. There have been a lot of positive comments on having our local law enforcement carry the flags for the parade. Steven stated he would like to hold the Taste of Panguitch in October with some changes. On August 18 there will be a 3 on 3 basketball tournament. The car show is scheduled for September 12th. This year the cars will line up on Main Street for a light show.

THE MEADOW SUBDIVISION FINAL PLAT

Planning and Zoning approved the recommendation of The Meadow Subdivision Final Plat.

Mark Boshell moved, seconded by Mike Sarles to approve the business license for Savage Apparel. The motion passed with all in favor.

DEPARTMENT REPORTS

Courts – Court has not been held due to Covid19.

Marilyn Bulkley Memorial Park – Students from SUU have been cleaning up the Marilyn Bulkley Memorial Park and will be completing a plan to improve the park. Panguitch Prevention Coalition has received a \$20,000 grant to help make the park a place for positive family use. Tyce Palmer is looking into money from the Upper Sevier River Conservation District to fortify the river banks.

Lions club – Dean Sheffer from the Lions Club is looking into a community green house to grow vegetables for the senior citizens.

Balloon Rally – It has been fourteen days since the Balloon Rally and our community hasn't seen any spikes in Covid19 cases.

Fuel project – The 25 acre fuels project around the water tanks is complete.

Old Skool Motorcycle Rally – Panguitch had 426 registered motorcycles riders for the Old Skool Motorcycle Rally, the event well.

Garfield County Insider – All the collected newspapers from the city office have been delivered to SUU to be archived.

Water tanks – The south water tank has a sagging lid that needs to be replaced. There was discussion about grant opportunities.

UDOT – UDOT has a planning grant that City Manager Lori Talbot would like to apply for.

Master plan – Jones and Demille has completed a draft for the Master Plan Children's Justice Center – A thank you card was received from the Children's Justice Center.
