PRIZES:

FIRST PLACE AVERAGE IN EACH EVENT: Choice of a SADDLE or a \$1,000 CHECK will be given, except in the case of events with **five or less contestants** where a \$500 CASH prize will be awarded.

SECOND AND THIRD PLACE AVERAGE IN EACH EVENT: Buckle to each place.

GO-ROUND WINNERS IN EACH EVENT: 1st place \$100 cash and buckle, 2nd place \$75 cash, 3rd place \$50 cash.

ALL-AROUND COWBOY AND COWGIRL: Trophy saddle to each!!

RODEO PERFORMANCES:

Thursday, July 22nd - 9 a.m. and 6:00 p.m.

Friday, July 23rd - 9 a.m. and 6:00 p.m.

Saturday, July 24th - 6:00 p.m. (Finals)

There will be two goes (Thursday-Friday Performances) with the top ten in each event returning for the finals Saturday Night. If there is less than or equal to five entries in an event, there will be three head and an average.

There will be a team roping jackpot on Saturday morning following the parade. There will a 4D barrel race during the event.

There will also be a breakaway jackpot.

MANDATORY CHECK-IN: Check-in will be Wednesday, July 21, 2021, from 5:00-10:00 pm. A \$25 fine will be assessed for anyone who does not check in at this time.

GATE PRICES: \$10.00 for adults, \$5.00 for children 4-11 and \$25.00 for a family pass. An all performance pass will be available for \$15.00 - adults and \$10.00 - children. Please purchase passes at the office when you check in.

A short grounds meeting will be held 30 minutes before each performance.

CANCELLATIONS AND REFUNDS:

Any cancellations must include a written doctor or vet slip and will be subject to a \$25 cancellation fee. Fees will not be refunded after the draw for position is complete. All refunds of stalls must be arranged before performances have started; a \$5 processing fee will be charged.
