Those present at the City Council meeting were Mayor Kim Soper, City Manager Lori Talbot, City Recorder Tyrissa Howell, Attorney Barry Huntington, Council Members Paul Dastrup, Mark Boshell, and Tracy Wright. Council Member Mike Sarles was in attendance via Zoom. Council Member David Dodds joined by phone.

Others present were Sheriff Eric Houston, Stevie Julander, Glen Partridge, Durrell Darr, John Crandall, Ezra Nielsen and Joni Nielsen.

The meeting was called to order at 5:30 pm.

OPENING CEREMONY

Mayor Kim Soper conducted the opening ceremony.

ADOPTION OF THE AGENDA

Paul Dastrup moved, seconded by Mark Boshell to adopt the agenda. The motion passed with all in favor.

APPROVAL OF THE MINUTES

Tracy Wright moved, seconded by Mike Sarles to approve the minutes. The motion passed with all in favor.

OFFICER REPORT

Sheriff Eric Houston stated that all the search and rescue radios have been upgraded. Three officers will graduate from POST in August and another officer will attend soon. There were several problems with dogs at the Balloon Rally. The Sheriff asked if directional signs for traffic could be added to the road barricades. The Council requested assistance from the officers in dealing with the issue of kids riding ATVs and golf carts on city streets.

SWAYZE BURTON, NATHAN AND ERIC HOUSTON ANNEXATION CERTIFICATION

Mark Boshell moved, seconded by Paul Dastrup to approve the certification of the Swayze Burton, Nathan and Eric Houston Annexation. The motion passed with all in favor.

SHORT TERM RENTAL – STONEY FARMS/EZRA NEILSEN AT 250 N 400 W

A new plan was provided showing the barn in the new location and the farm store moved across the road for parking.

Paul Dastrup moved, seconded by Tracy Wright to approve Stoney Farms at 250 N 400 W. The motion passed with all in favor.

EXECUTIVE SESSION

Tracy Wright moved, seconded by Mike Sarles to exit the executive session. The motion passed with all in favor.

JOHN CRANDALL

The mayor stated the Council will uphold the last decision made, which requires all materials be moved from the City Right of Way. Mr. Crandall asked if that would apply to all residents. The mayor clarified that it would only apply when a written complaint is received.

DEPARTMENT REPORTS/CALANDER

Planning and Zoning- The City Council met with the Planning and Zoning Committee on July 3rd and went through the Residential Dense Housing Zone. This will be on the next agenda.

Library – The library will have struggles between librarian directors. It may be difficult to keep it open enough hours to keep it certified.

New Truck – New toolboxes were received today for the new work truck.

Short Term Rentals – Council Member Paul Dastrup asked how many short term rentals there are in Panguitch. There are around 54.

ATVs – The City Council asked for ATVs to be added to the next agenda.

Secondary Water – The secondary water is off today to try to help with the low pressure.

Potholes – The Council thanked the guys for their work fixing the potholes by the elementary.
