The meeting was called to order at 5:30 p.m.

OPENING CEREMONY

Mike Sarles conducted the opening ceremony.

ADOPTION OF THE AGENDA

Mike Sarles moved, seconded by Cindy Stewart to adopt the agenda. The motion passed with all in favor.

APPROVAL OF THE MINUTES

Tracy Wright moved, seconded by Mike Sarles to approve the minutes. The motion passed with all in favor.

SIGNAGE – ON THE RUN AT 195 N MAIN

Mike Sarles moved, seconded by Tracy Wright to approve the signage for On the Run at 195 North Main. The motion passed with all in favor.

BUSINESS LICENSE – THE GOLDEN SPUR AT 429 N MAIN

Tracy Wright moved, seconded by Mike Sarles to approve the business license for The Golden Spur at 429 N Main. The motion passed with all in favor.

BUSINESS LICENSE – THE WELLNESS SPOT/DURRELL DARR AT 75 E CENTER

Mike Sarles moved, seconded by Tracy Wright to approve the business license for The Wellness Spot at 75 E Center. The motion passed with all in favor.

PENDING BUSINESS/DEPARTMENT REPORT

Library – The library received some furniture and shelving from the Lehi Library. **Innovation Hub** – Mike Sarles has been in discussions with USU regarding the potential use of the Innovation HUB as a USU campus site.

Day of Service – The City Council discussed potential projects for the 9/11 day of service at the Marilyn Bulkley Memorial Park, scheduled to take place on Saturday, September 7th.

Airport – The airport project began today, with an expected completion in six weeks, but it could take longer.

24th of July Parade – There have been complaints about the water fights during the 24th of July parade. Next year, there will be notices before the parade outlining the rules for water fights.

Flooding – There was flooding in different areas of town over the weekend. The culverts require cleaning and repairs.

Landfill – The BLM conducted a site visit to the landfill and we proposed expanding it to the east. However, the presence of a large population of prairie dogs in that area led to the BLM opposing the expansion.

Secondary Water Project – The estimate for the secondary water project is \$4 million. If Panguitch City decides to participate in the project, the city's share would be \$1 million.

Panguitch Lake Dam – The Panguitch Lake dam will take 1.2 million to repair or 4.5 million to replace. Don L. Ipson is working on securing funding for the dam.
